COOPERATION BETWEEN SOCIAL PARTNERS YET THERE IS A FEELING TODAY THAT THIS HISTORY HAS DRAWN TO A CLOSE THAT OUR POST INDUSTRIAL WORLD DEMANDS SOMETHING DIFFERENT SOMETHING OUR TRADITION OF COLLECTIVE BARGAINING AND COLLECTIVE AGREEMENTS CANNOT GIVE US WHAT INFORMATION AND INSIGHT CAN WE GATHER TO VERIFY OR CHALLENGE THIS FEELING THIS WAS THE FIRST MAJOR QUESTION ADDRESSED BY THE DISTINGUISHED DELEGATES TO THE TWENTY SEVENTH WORLD CONGRESS OF LABOUR AND SOCIAL SECURITY LAW HELD AT MONTEVIDEO 2 5 SEPTEMBER 2003 THE AIM OF THE CONFERENCE WAS TO DISCOVER CURRENT PROBLEMS REGARDING THE EXISTING STRUCTURES AND FUNCTIONS OF COLLECTIVE BARGAINING IN INDUSTRIALIZED COUNTRIES TODAY PROBLEMS READILY IDENTIFIABLE IN THE CONTEXT OF ECONOMIC GLOBALIZATION FALLING UNION DENSITY THE INCREASE IN ATYPICAL AND KNOWLEDGE BASED WORKERS AND THE TERTIARIZATION OR DECLINING ECONOMIC IMPORTANCE OF MANUFACTURING BASED INDUSTRY THIS BULLETIN CONTAINS SOME OF THE MOST IMPORTANT PAPERS DEVOTED TO THIS THAT IN PRIVATE ENFORCEMENT REGULATION SHOULD BE INSTITUTED AS THE MINIMUM REQUIREMENT IN PRIVATE LAW OUTLINING THE DIFFERENT TYPES OF FINANCIAL CRIME AND ITS IMPACT THIS BOOK IS A USER FRIENDLY UP TO
