address delivered before the soldiers club at wellesley may 30 1894 if all that has been said by orators and poets since the creation of the world in praise of woman was applied to the women of america it would not do them justice for their conduct during this war lincoln mr chairman and ladies and gentlemen memorial day popularly known as decoration day was established by the grand army of the republic the first post of which was organized on the sixth day of april 1866 at decatur ill may 5 1868 a general order was issued by john a logan commander in chief of the grand army designating the thirtieth day of may for the purpose of strewing with flowers or otherwise decorating the graves of comrades who died in defence of their country during the late rebellion no particular form of ceremony was prescribed but posts and comrades were left to arrange in their own way such fitting services as circumstances might permit on that day without legislative sanction or executive proclamation the grand army posts and the people in twenty seven states responded to this call with such services and
