expressed value creating goals i chose the time period from 1998 2001 for my analysis unfortunately the annual report 2001 was published merely days before the dead line of this term paper but nevertheless i tried to include the latest figures in my analysis 1 abb annual report 2000 p 22 work family researchers have had much success in encouraging both organizations and individuals to
