THE PLAN ALSO AIMS TO CREATE 4 MILLION NEW JOBS, SAVE HEALTH COSTS, AND PROTECT COMMUNITIES FROM OIL DRILLING. IN A MARATHON TWO-DAY HEARING, THE CALIFORNIA AIR RESOURCES BOARD VOTED ON NEW REGULATIONS DESIGNED TO LIMIT POLLUTION FROM LOCOMOTIVES AND CARGO TRUCKS. CHAIR CALIFORNIA AIR RESOURCES BOARD LIANE M. RANDOLPH OPENS A NEW WINDOW. THE CALIFORNIA AIR RESOURCES BOARD IS ONE OF SIX BOARDS, DEPARTMENTS, AND OFFICES UNDER THE UMBRELLA OF THE CALIFORNIA ENVIRONMENTAL PROTECTION AGENCY. IN FEBRUARY 2022, THE CALIFORNIA AIR RESOURCES BOARD (CARB) REACHED A SETTLEMENT WITH PHOENIX CO. LTD.
