this intelligence guide was prepared in response to requests from law enforcement executives for guidance in intelligence functions in a post september 11 world it will help law enforcement agencies develop or enhance their intelligence capacity and enable them to fight terrorism and other crimes while preserving community policing relationships the world of law enforcement intelligence has changed dramatically since september 11 2001 state local and tribal law enforcement agencies have been tasked with a variety of new responsibilities intelligence is just one in addition the intelligence discipline has evolved significantly in recent years as these various trends have merged increasing numbers of american law enforcement agencies have begun to explore and sometimes embrace the intelligence function this guide is intended to help them in this process the guide is directed primarily toward state local and tribal law enforcement agencies of all sizes that need to develop or reinvigorate their intelligence function rather than being a manual to teach a person how to be an intelligence analyst it is directed toward that manager supervisor or officer who is assigned to create an intelligence function it is intended to provide ideas definitions concepts policies and resources it is a primera place to start on a new managerial journey every law enforcement agency in the united states regardless of agency size must have the capacity to

understand the implications of information collection analysis and intelligence sharing each agency must have an organized mechanism to receive and manage intelligence as well as a mechanism to report and share critical information with other law enforcement agencies in addition it is essential that law enforcement agencies develop lines of communication and information sharing protocols with the private sector particularly those related to the critical infrastructure as well as with those private entities that are potential targets of terrorists and criminal enterprises not every agency has the staff or resources to create a formal intelligence unit nor is it necessary in smaller agencies this document will provide common language and processes to develop and employ an intelligence capacity in state agencies across the united states as well as articulate a uniform understanding of concepts issues and terminology for law enforcement intelligence lei while terrorism issues are currently most pervasive in the current discussion of lei the principles of intelligence discussed in this document apply beyond terrorism and include organized crime and entrepreneurial crime of all forms drug trafficking and the associated crime of money laundering for example continue to be a significant challenge for law enforcement transnational computer crime particularly internet fraud identity theft cartels and global black marketeering of stolen and counterfeit goods are entrepreneurial crime problems that are increasingly being relegated to state agencies to investigate simply because of the volume of criminal incidents similarly local law enforcement is being increasingly drawn into human trafficking and illegal immigration enterprises and the often associated crimes related to counterfeiting of official documents such as passports visas driver s licenses social security cards and credit cards all require an intelligence capacity for state as does the continuation of historical organized crime activities such as auto theft cargo theft and virtually any other scheme that can produce profit for an organized criminal entity to be effective the law enforcement community must interpret intelligence related language in a consistent manner in addition common standards policies and practices will help expedite intelligence sharing while at the same time protecting the privacy of citizens and preserving hard won community policing relationships
